CORRIGENDUM-2 To Advertisement No. AIIMS/Rajkot/Admin/Recruitment/NF/6/2023-24/5469 dated 07th October 2023

- Further to our Corrigendum issued vide AIIMS/Rajkot/Admin/2023-24/5536 dated 10th October 2023, following additional amendments/modifications to the original Advertisement No. AIIMS/Rajkot/Admin/Recruitment/NF/6/2023-24/5969 dated 07th October 2023 are enumerated below:
- SCHEME AND BROAD SYLLABUS OF EXAMINATION (CBT)**
 - It is clarified that "**Indicative syllabus**" given out against each posts through our original Advertisement dated 07th October 2023, is just a broad guideline, based on which the question papers for the CBTs could be prepared. However, Candidates are advised to prepare according to basic subject knowledge of the concerned post.
 - In view of the above, even if the Indicative syllabus for few posts is not found mentioned, the following **Final Broad Syllabus Scheme** would be followed for conduct of CBTs as mentioned below for each or group of certain posts as elaborated below: -
 - For the posts listed at Serial Nos. 1,3,7,8,9,10,13,14,15,16,18,22,23,25,27,28,34,35 & 36 in our Recruitment Notice Dated 07th October 2023.

E. For Group A posts listed in our Recruitment Notice Dated 07th October 2023 at Sr. No. 4,5,11 & 12, the mode of Selection will be based on the **performance on the Interview only (by a designated independent Expert Committee)**. However, the Institute may hold a Screening Test or any other screening process at Institute level only (purely based on the general subject knowledge of concerned post), to shortlist the candidates in the ratio of 1:6 to be called for the final Interview in only those posts against which more than 6 candidates will apply. The decision of the Institute in this regard will be final. **The performance in Screening Test will carry "No Weightage" and the Final selection will be based on the performance during of the Interview only.** Hence, no indicative syllabus for Group 'A' Posts can be further specified.

3. **Specified/Suitable Category of disabilities for the posts for PwBD candidates** will be strictly as per the Ministry of Social Justice and Empowerment, Govt. Of India, Notification No. 38-16/2020-DD-III dated 04.01.2021 and as decided by the appointing authority considering the functional/physical requirements of the posts. The Institute may further verify the authenticity of the Certificates of Disability and examine suitability of the candidate in terms of functional requirements before appointment. In this regard, the decision of the Institute will be final.





4. **Age relaxation** Permissible to candidates of various categories beyond the prescribed upper age limit of the advertised posts is further clarified/modified as under for better understanding:

Sr. No.	Category	Age Relaxation	Remarks.
a)	OBC – Non Creamy Layer (NCL)	3 Years	Only for posts reserved for OBC-NCL
b)	SC/ST	5 Years	Only posts reserved for SC/ST
c)	PwBD	10 Years	With not less than 40% of specified disability and provided that the age of applicant shall not exceed 56 years.
d)	Central/State Government and Autonomous Institutions of Central & Governments	5 Years	With 3 years of continuous service and working in the post which is in the same line or allied cadres.
e)	Ex-Servicemen (E-SM) /Commissioned Officers	Length of Military Service increased by 3 Years, subject to in spite of relaxation, the age does not exceed the Maximum age limit	
f)	Candidates belonging to SC/ST/OBC Category who are also coming under the category of Ex-Servicemen or PwBD or Central Government Employees will be eligible for grant of cumulative age-relaxation under both categories, if they apply for the reserved for their category.		
g)	Age relaxation to any other category will be as per the latest Government of India/DoPT rules.		
h)	All the above-mentioned relaxations in upper age limit shall be permissible only on fulfilment of terms and conditions mentioned in the relevant rules.		
i)	All other Age Relaxations criteria as already given in the original Recruitment Notice dated 07 th October 2023 will also stand to exist.		

5. **Applications Fees/Fees Exemption:** It is clarified that since AIIMS Rajkot being a Central Autonomous Body and its does not come under UPSC based exam conduct rules, so the fee structure/Exemption as already specified, **will prevail**.
6. It is further intimated to all Candidates applying or already Registered against various posts advertised, that their Registration & Final Form submission will not be considered valid/acceptable until the Fees payable against each post is paid and receipt for same is generated by the system. Hence, all the candidates who have already registered online are

7. **For the post of Medical Officer AYUSH (Serial No. 11)**, it is further clarified that this post, presently is being considered for **Ayurveda Stream only**. Accordingly, candidates holding relevant BAMS degree may only apply. Vacancy as and when allotted for other streams of AYUSH, would be published subsequently.
8. **Choice of Test Centers:** It is clarified that the priority (1,2 & 3) will now have to clearly specified by the candidates while filling the Application forms. The option of exercising the same will be shortly enabled on the online Registration module on our website. However, for candidates who have already completed the registration process, they would be allowed to Edit and update the choice of Test Centers priority wise through their respective login ID's. So all **candidates must clearly specify the Test Center Options**.
9. **Essential Qualifications:** - Refer **Serial No. 29**, where Essentials qualification regarding post of "Store Keeper" was given.
- **Under the Part I Graduate:** The condition of "One Year Experience in handling Store" is hereby cancelled/withdrawn.
