In reference to Non-faculty recruitment Adv No. F.No/AIIMS/Rajkot/Admin/Recruitment/Non-Faculty/ 2023-24/1211 dated 13.03.2024 for the posts on deputation basis at AIIMS Rajkot.

The eligibility of the candidates is categorized as:

- 1. Eligible: Can attend the personal interview
- 2. Provisionally Eligible: Can attend the personal interview subject to submission of additional documents latest by 17th August, 2024 via speed/registered post (aiims.rajkot.recruitment@gmail.com)
- 3. Ineligible: Cannot attend the personal interview.
- In case of any "Name mismatch" in the application form and documents submitted, the candidate shall have to furnish a notarized affidavit, countersigned by the candidate as per the format mentioned below.
- In case any certificate is submitted in any regional language, the candidate has to:
- i. Submit the English/ Hindi translation of the certificate issued by the issuing authority.

OR

- ii. Submit the English/ Hindi translation of the certificate in the form of a notarized affidavit countersigned by the candidate.
- No Objection Certificate (NOC) and Experience certificates shall be issued by the competent authority/ Head of the Institute /Administrative Head of the Institute.

- NOC submitted shall have to be obtained after the publishing date of the Non-faculty recruitment advertisement (13th March 2024).
- In case, the candidate does not agree to the decision of Eligibility Screening Committee, he/she may choose to represent his/her case and can Email his/her grievance to email ID: aiims.rajkot.recruitment@gmail.com along with necessary proof and documents latest by 17th August, 2024.
- Final list of eligibility of the candidates will be published on the website of AIIMS Rajkot after 17th August, 2024. Personal interview shall be subject to verification of original documents on the day of interview.
- Date of interviews shall be notified on AIIMS Rajkot website in due course.
