

## NOTICE: AIIMS/Rajkot/Admin/Recruitment/NF/06/2023-24/5469 dated 7th October 2023 (Queries Related to Questions in the Phase II CBTs)

- Non-faculty Phase II CBT based exams were conducted by AIIMS Rajkot on 7<sup>th</sup> January 2024 for various posts as advertised & intimated vide Important Notice AIIMS/Rajkot/Admin/2023-24/7105 dated 24<sup>th</sup> December 2023.
- 2. Queries & Objections if any are invited from the candidates who have taken the CBTs, regarding "CBT based Questions" for all the posts for which exams are now over.
- 3. Your queries & objections to be mailed to us at <u>aiims.rajkot.recruitment@gmail.com</u> latest by 10<sup>th</sup> January 2024 23.55 hours, No request on the same would be entertained subsequently.
- The decision of Experts & Institute about queries or objections raised thereon will be Fair & Final & will be communicated to all concerned.
- 5. During the conduct of Phase II CBT exams for all the 12x Non-Faculty post it was informed to all candidates appearing in the CBT that they were free to note down /Submit the queries/representation/Objections related to questions/answers refracted in their respective CBT questions papers after the submission of their responses. It is intimated that most of the candidates who have submitted their queries/objections on the questions/answers are being duly considered by the concerned Experts and if found acceptable, all the affected candidates who have applied for the said post would be given 1(one) mark for each such questions/answers.
- 6. In case there was a repeated question which appeared twice/thrice in any question paper for any post and if the candidate has attempted the same and in case the answer is found correct, then the candidates will receive 1(one) mark for each correct answers in spite of being repeated questions/answers (only if the answer attempted is correct for each of the repeated questions)
- 7. In addition, as per policy in vogue, an additional notice of 48 hours with time of publication of this notice is being given to all candidates to submit their queries or objection to any question/answer attempted in the Phase II CBT conducted for the 12 x Posts on 07 Jan 24. No representations would be acceptable after the above given time deadline.
- 8. It is further intimated to all the candidates that the Question paper for the CBTs conducted will not be shared or disclosed owing to a confidentiality clause undertaken by the Institute with the conducting agency. Hence, same may please be not requested, since all the candidates were allowed and intimated to note down the same on a paper during the conduct of CBT itself and many candidates have already submitted the same, which will be duly referred to concerned expert for any discrepancy.
