- 2. Only those candidates, who are found to be eligible/ provisionally eligible subject to decision of the competent authority after document verification on the scheduled day, shall be permitted to appear before the Standing Selection Committee (SSC).
- 3. Candidates are required to report at 10:00 AM for Document verification.
- 4. Original "No Objection Certificate" (NOC) for candidates currently working in Central Government/ State Government/ Autonomous bodies of Govt. of India is mandatory.
- 5. Participation in Interview does not guarantee selection. The proceedings of the SSC are confidential and the methodology adopted by the SSC for selection of the candidates is at the discretion of the committee. No information pertaining to the proceedings of the SSC shall be divulged to any candidate at any stage. Only such candidates who are agreeable to the above condition may appear for document verification and for Interview before the SSC.
- 6. Separate Interview call Letters are being issued to the eligible/provisionally eligible candidate along with a list of VALID mandatory documents, in original, to be carried by the candidate.
- 7. No TA/DA shall be paid to the candidates for the Interview. The candidate should make arrangements for stay at own cost in case of spill over of Interview for the next day.
