The rolling advertisement will be limited to seats which remain unfilled in the previous recruitment cycle; eligibility will be determined with respect to cut-off dates for respective rolling cycle. Except for first cycle of notification, further notifications would be published on AIIMS Rajkot website.

AIIMS RESERVES THE RIGHT TO COMBINE TWO OR MORE CYCLES. ONCE the seats are filled, no more applications will be considered.

All India Institute of Medical Sciences, Rajkot, Gujarat is a Central Autonomous Body (CAB) formed by an Act of the Parliament. The administrative ministry is *Pradhan Mantri Swasthya Surakasha Yojana* division of the Ministry of Health and Family Welfare, Government of India. AllMS, Rajkot adheres to AllMS Act, Rules and Regulations available on the website of the PMSSY and also on website www.aiimsrajkot.edu.in. The posts of Financial Advisor (FA); Executive Engineer (Civil); Executive Engineer (Electrical); Administrative Officer; Accounts Officer and Assistant Administrative officer, Assistant Controller of Examination (ACE), Nursing Superintendent (NS) and Medical Superintendent are governed by AllMS, Rajkot.

The candidates are expected to apprise themselves of provisions of AIIMS Act, Rules and Regulations before deciding to apply for this deputation. The definition of 'analogous post' shall be governed by DoPT instruction dated 7th March 1984. A person holding higher pay grade on the cut-off date will not be considered eligible for the post.
